## IMPF

INDEPENDENT MUSIC PUBLISHERS INTERNATIONAL FORUM The Independent Music Publishers International Forum (IMPF) is a group of international independent music publishers who share a vision for the future of music publishing. Our industry is being affected by some dramatic changes. Digitally delivered music sees consumers and platforms seeking cheaper alternate ways to provide access to music. Mergers and acquisitions mean larger companies are dominating the market. Online licensing is fast becoming the major source of income for publishers and writers globally, across markets, but the share and splits are unfair.

The conversation on all matters concerning our business is not fully **benefiting from the contribution and perspective of independent publishers** and therefore can lack the diversity and fairness we know is necessary for the good of the wider industry.

**IMPF** was established in 2013, as a network and meeting place for music publishers from around the world. We created a Forum for us to keep track of developments, discuss the challenges we face and propose solutions. The Forum undertakes research on points of interest, provides its members with information on regulatory and legal developments, discusses positions during meetings, and delegates members to represent our views at all levels. As a worldwide grouping of 190 member companies, we want to take advantage of the incredible opportunities on offer; our music should be available on every service, licensed easily and without borders; and we are adamant that our writers and our companies should be rewarded fairly for their collective work.

IMPF is based in Brussels, the home of the European Institutions and with members and outreach in the USA and DC we are the first to know, discuss and act on policy and key legislation that affects our writers and companies. IMPF is an associate member of <u>CISAC</u> (International Confederation of Societies of Authors and Composers) and <u>ICMP</u> (International Confederation of Music Publishers) and works closely with the CMO members of CISAC at national level.

IMPF also works with <u>IMPALA</u>, <u>ECSA</u> and <u>GESAC</u> on European affairs. IMPF has a memorandum of understanding with <u>AIMP</u> (Association of Independent Music Publishers), a charter of cooperation with <u>IMPEL</u>, the licensing hub for independent music publishers, and a strategic alliance with <u>The</u> <u>Ivors Academy</u> to strengthen ties between music creators and publishers. IMPF also liaises at international level with <u>CIAM</u> (International Council of Music Creators) in this regard.

IMPF joins the Standing Committee on Copyright and Related Rights (SCCR) at <u>WIPO</u> and is a member of the Advisory Board of <u>WIPO for Creators</u>. IMPF also supports the <u>Credits Due</u> initiative. IMPF is a stakeholder to the European Observatory on Infringements of Intellectual Property Rights of the European Union Intellectual Property Office <u>EUIPO</u> and is also a member of the <u>Pro Music</u> international coalition which promotes the myriad of different ways people can enjoy music safely and legitimately online. IMPF sits on the Advisory Board of <u>Fair Muse</u> a project "Promoting Fairness of the Music Ecosystem in a Platform-Dominated and Post-Pandemic Europe." IMPF has been an early supporter of the new platform <u>CLIP</u>, sitting on its advisory board on behalf of our members and the worldwide creative community. IMPF has a best practice Code of Conduct and Ethics and partners with <u>Keychange</u> to work towards gender balance on the Boards, Committees and activities of IMPF. IMPF is a memer of the <u>Human Artistry Campaign</u> coalition.



**IMPF** is the recipient of a <u>Creative Europe</u> grant to build capacity of independent music publishers. This <u>IMPF network project</u> will run for three years and is co-funded by the European Union. The project aims to empower in the first instance, independent European publishers, but with benefits for all IMPF members globally. The project runs from 1st March 2022 to 1st March 2025.
